



## VANCOUVER ISLAND JUNIOR HOCKEY LEAGUE 2024-2025 STANDARD PLAYER AGREEMENT

Our ownership, management and coaching staff are pleased to welcome you to our organization for the 2024-2025 VIJHL season. By signing this Standard Player Agreement, you confirm you are liable for the payment of VIJHL League fees and team fees as listed below:

**VIJHL LEAGUE FEE AMOUNT: \$ 1,500**

The VIJHL league fee of \$1500.00 must be paid in full by 5pm Tuesday September 3, 2024. Players joining the league after September 3rd must pay the applicable fee prior to playing their first game. This fee is directly to the league by e-transfer at [vijhlleague@gmail.com](mailto:vijhlleague@gmail.com).

**If the League fee has not been received, the player will be ineligible to play.**

VIJHL Team fees do not include Billet fees. Please refer to page 2 of this agreement

A non – refundable deposit of \$ \_\_\_\_\_ (max. \$2,500) is applicable on signing this SPA.

This deposit is applied to team fees and is non-refundable unless a player is signed to a higher-Level League (BCHL, any MAJOR JUNIOR or USHL Team).

Team fees are paid directly to each team and must be submitted in full, or with a signed installment agreement, before September 3, 2024. Players joining the league after September 3rd must pay the applicable team fee prior to playing their first game.

All non-Canadian players will be responsible for the cost of any/all out of country fees such as visas and immigration documentation. All non-Canadian athletes must carry primary medical insurance that includes travel and sports injury coverages. The player and their families understand that VIJHL Coverage is secondary coverage.

## I. CONDUCT

By signing this agreement, you commit to abiding by the terms of this contract as well as all rules and regulations set forth by Vancouver Island Junior Hockey League and respective approved affiliate leagues and governing bodies. Our expectation is that your behavior and interactions with others will demonstrate the characteristics of respect, commitment, hard work, honesty, integrity, and professionalism.

## II. DISCIPLINE

Team staff will deal with any disciplinary incidents that may occur using one or more methods:

1. Verbal warning with written documentation
2. Disciplinary action with written documentation
3. Suspension and possible team release from the team with written documentation

Each incident shall be dealt with on an individual basis and in a fair manner, with a warning or disciplinary action depending on the severity of the infraction, all written documentation will be submitted to the President, Vice-President and Director of Player Safety.

#### **IV. REFUNDS**

In the event a player is released by management for non-disciplinary reasons, the VIJHL LEAGUE FEE is refundable as follows:

October 1 to November 15	<b>\$1,000</b>
November 16 to December 31	<b>\$ 500</b>
January 1 to February 15	<b>\$ 250</b>

In the event a player is released by management for non-disciplinary reasons, the VIJHL TEAM FEE paid is refundable as follows:

<b>IF RELEASED BY</b>	<b>REFUND %</b>
August 15 to September 30	<b>80%</b>
October 1 to November 15	<b>60%</b>
November 16 to December 31	<b>30%</b>
January 1 to February 15	<b>15%</b>

**Any player registering up to September 30th is subject to full league and team fees. Fees for any player joining the VIJHL after September 30th will be consistent with the refund schedule outlined above.**

**Any player traded between teams within the VIJHL will not receive a refund nor will they be charged any additional fees by the new team. Funds will be transferred between teams.**

**If, at any time during the season, a player leaves a team on his own self initiative there will be no refund of either VIJHL League or Team Fees.**

**The final registration deadline in the VIJHL is February 15th, no refunds will be issued after that date.**
